**NOTIFICATION**

Bhubaneswar, dated the **1st July, 2020.**

No. COE-14/20/3501/CHSE/In pursuance of the Government of Odisha, Deptt. of School & Mass Education Order No. 9281/SME, dtd. 01.07.2020, Govt. have been pleased to approve the proposal of the Examination Committee of CHSE finalized in its meeting on dt. 30.06.2020 for cancellation of remaining examinations and adoption of alternative method of awarding marks as mentioned below:

- 1 Examinations for the rest of the sittings of Annual Higher Secondary Examination, 2020 which were scheduled from 23<sup>rd</sup> March, 2020 to 28<sup>th</sup> March, 2020 stand cancelled.
- 2 Assessment of the performance of the students in the cancelled examinations will be done based on the assessment scheme as suggested by the Examination Committee of the Council which is approved by the Government in the Department of School & Mass Education for declaration of results of Annual H.S. Examination, 2020. The said scheme is mentioned in Para- 5 below:
- 3 However, CHSE will conduct an Optional Examination in the subjects in which examinations were scheduled to be conducted from 23<sup>rd</sup> March, 2020 to 28<sup>th</sup> March, 2020 as soon as conditions are conducive, as assessed and decided by the State Government. Candidates whose results will be declared based on the above assessment scheme will be allowed to appear the Optional examination to improve their performance, if they so wish. **However, the marks obtained by a candidate in the Optional examination will be treated as final for those who opt to take the examination.**
- 4 For Annual Higher Secondary Examination, 2020, the result declared by CHSE under Sl. No. 2 above will be considered as final unless the students opt for Sl. No. 3 above.

## 5 Scheme for Assessment :

- a) For the students who have completed all the examinations, their results will be declared based on their performance in the examinations.
- b) For the students who have appeared in the examination in more than 3 papers, the average of the marks in theory obtained in best three performing papers will be awarded in the theory papers in which examination have not been conducted.
- c) For the students who have appeared in the examination in only 3 papers, the average of the marks in theory obtained in best two performing papers will be awarded in the papers in which examination have not been conducted.
- d) (i) For the Compartmental examination candidates, who have appeared all the required papers, marks of the paper(s) will be declared on the basis of their performance.  
(ii) For Compartmental examination candidates, who have partly appeared in the required papers, the average of the marks obtained in any theory paper/papers appeared in AHSE 2020, will be awarded in the paper(s) in which examinations have not been conducted.  
(iii) For Compartmental examination candidates, whose examinations of any paper has not been conducted in AHSE 2020, such candidates will be awarded the average of the best 3 (if the candidate has secured pass marks in more than 3 papers in the last qualifying examination); average of best 2 (if the candidate has secured pass marks in 3 papers in the last qualifying examination); average of 2 papers (if the candidate has secured pass marks in 2 papers in the last qualifying examination) of the theory marks obtained by him/her in the last qualifying examination.
- e) For calculation of average marks at (b), (c) and (d) above, the practical marks will not be taken into consideration.
